



DEED OF TRUST

AND WHEREAS the executive committee in it meeting dated 08.09.2007 has decided to appoint two new trustees as mentioned in part One. In pursuance of the same the CONTINUING TRUSTEES propose to appoint NEW TRUSTEES as trustees of the trust.

AND WHEREAS it is desired by the parties to appoint the new trustees by a deed and to transfer the properties and assets of the trust to the new trustees alongwith the continuing trustees so as to vest the same in them.

NOW this deed witnesseth as under

1. That the continuing trustees in exercise of the powers conferred on them by the said trust deed appoint NEW TRUSTEES of the said trust for all purposes to act jointly with the CONTINUING TRUSTEES in the said trust and declare that the continuing trustees do hereby grant, convey and transfer all the properties and assets to have and hold the same unto the new trustee alone and jointly with the continuing trustees to the use and upon the said trust and with the same powers, provisions and obligations as are specified in the said trust deed to the intent and purposes and as if the new trustee was originally appointed as trustee by the said deed of trust.
2. That the executive committee as per clause 16 shall stand amended as hereunder




